

ALGERIAN CITIZENS APPLYING FOR A VISA TO VISIT THE PHILIPPINES

The processing period for visa applications is approximately **two weeks** and the fee is **Forty US Dollars (\$ 40.00)** for a Single Entry Visa. E-mail us at Tripoli.PE@dfa.gov.ph with subject line: Attention: Visa Section VISA APPLICATION of Last Name, First Name. Attach **scanned copies** of the filled up application form and other documents required.

The actual issuance of visas to Algerian nationals will take place during the Embassy's mobile consular outreaches in **Algiers** or in **Tunis**. The schedules are announced on the Embassy website.

Following are the **requirements** for visa applications of Algerian citizens:

1. Accomplished **Visa Application Form** (attached)
2. Present **original passport** and submit **photocopies of passport data page(s)**. Passport must be valid for at least **six (6) months beyond the intended period of stay** in the Philippines;
3. One (1) recent passport size photo (*not more than six months old*) signed by the applicant on the left portion;
4. Bank statement of personal accounts as proof of applicant's financial capacity to travel
5. Either of the following:
 - a) **If applicant is employed**: Letter of Guarantee from employer/company sponsor stating and/or certifying the following:
 - i. Position and/or designation of the applicant
 - ii. Inclusive period of applicant's employment with the sponsor
 - iii. Monthly salary and
 - iv. No objection for applicant's travel to the Philippines
 - b) **If applicant is a business proprietor or partner or is self-employed**: present original and submit copy, with English translation of the Trade License with the name of the applicant as proprietor, partner or investor.

6. Either of the following:

- a) **Invitation/Reference letter from Philippine sponsor/contact person or company** together with the inviting person's passport or any valid ID and indicating the complete address and telephone number(s) in the Philippines; or
- b) **Hotel Booking in the Philippines.**

Additional Requirements:

- **If applicant has previous visit visa to the Philippines,** submit photocopy of the latest Philippine visa issued.
- **If applicant is married to a Filipino citizen,** submit photocopy of the attested marriage contract in English together with a copy of spouse's passport or ID;
- **If applicant is a minor, not employed:**
 - a) Notarized affidavit/Letter from parents or legal guardian guaranteeing that the applicant will have the parents/guardian's full financial support for international travel. This guarantee must be supported by documents certifying the sponsor's / guardian's financial capacity such as an employment/salary certificate, bank statement and trade license.
 - b) Copy of the birth certificate in English and passport copies or ID's of parents or guardian.

IMPORTANT:

Send by e-mail **scanned copies** of the filled up visa application form and the other documentary requirements for initial evaluation. There may be other requirements needed depending on the result of the evaluation. Incomplete requirements will not be processed. Payment of fees and actual visa issuance will take place during Consular Outreaches in Algiers and in Tunis.
